

## Fund Manager MannionDaniels supports UK aid grant holders

MannionDaniels is the fund manager of UK Aid Direct, a £150 million UK Government international aid fund. UK Aid Direct offers grants to UK based charities to achieve the Global Goals, improving life for the most vulnerable and marginalised people in the work.

We aim to build the capacity of the fund’s grant holders and work with them to make sure their projects deliver the best possible impact. On this page we share findings from our grant holder survey where grant holders told us their opinions on our support and our overall management of the fund.

### Key findings



75% of grant holders feel that the fund manager facilitates sufficient networking between grant holders



When asked the rate of experience of working with MannionDaniels compared to other fund managers, 56% of those who have experiences working with other fund managers considered MannionDaniels to be ‘much better’ or ‘better’ than other fund managers



83% of respondents felt that networking opportunities provide grant holders the opportunity to learn from each other, with 49% of these feeling this networking improved the success of their project



72% of respondents plan to reapply for UK Aid Direct funding

## Responding to COVID-19

Findings show that grant holders believe the fund manager has been **adaptable**, **flexible** and **understanding** with the regards to the challenges faced from COVID-19, and **88%** of respondents felt that MannionDaniels clearly communicated the fund's approach to the pandemic.


